ARTICLES OF ORGANIZATION

OF

PT 1-ON-1 TRAINING AND INVESTMENTS, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE 1 - NAME

The name of the limited liability company shall be PT 1-ON-1 TRAINING AND INVESTMENTS, LLC, ("Company").

ARTICLE 2 - ADDRESS

The principal place of business of the Company in Florida shall be 2377 Lake Debra Drive, Suite 1911, Orlando, Florida 32835 and the mailing address shall be the same.

ARTICLE 10 - INDEMNIFICATION

All references in these Articles of Organization to "member", "manager", "employee" and "agent" shall include the heirs, estates, executors, administrators and personal representatives of such persons.
