**ARTICLES OF ORGANIZATION  
OF  
LIGHTCAST COMMUNICATIONS LLC**

The undersigned, acting as the organizer of **LIGHTCAST COMMUNICATIONS LLC** under the Florida Limited Liability Company Act, Chapter 608, Fla. Stat., adopts the following Articles of Organization:

**ARTICLE I - Name:**

**ARTICLE V - Adoption of Operating Agreement:**

**ARTICLE VI - Initial Registered Agent and Office:**
