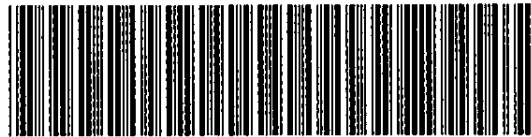

The term of the limited liability company shall be perpetual.

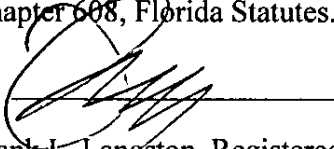

ARTICLE V MANAGEMENT

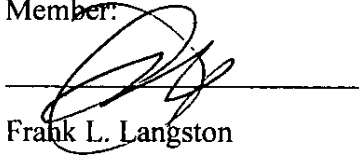
