ARTICLES OF AMENDMENT
TO ARTICLES OF ORGANIZATION OF

PDQ JACKSONVILLE – HODGES POINTE RESTAURANT CO., LLC

THE UNDERSIGNED hereby executes and swears to these Articles of Amendment to Articles of Organization of PDQ JACKSONVILLE – HODGES POINTE RESTAURANT CO., LLC, a Florida limited liability company (the “Company”), pursuant to the Florida Limited Liability Company Act, as amended, Florida Statutes § 608.411:


1. **Name of Company.** The name of the Company is PDQ JACKSONVILLE – HODGES POINTE RESTAURANT CO., LLC.

2. **Date of Filing of Articles of Organization.** The Company filed with the Florida Department of State Articles of Organization effective March 27, 2013 (the “Articles”).

3. **Amendment to Articles of Organization.** The first paragraph of the Company’s Articles is hereby amended by deleting the current text in its entirety and substituting the following in lieu thereof:

“1. Name. The name of this limited liability company is MVP H² Jacksonville – Hodges Pointe Restaurant Co., LLC (the “Company”), and it shall be formed as a limited liability company under Chapter 608 of the laws of the State of Florida.”
