The name of the limited liability company is "DREAMCATCHER ENDEAVORS, LLC."

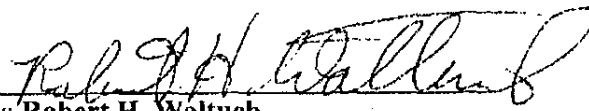

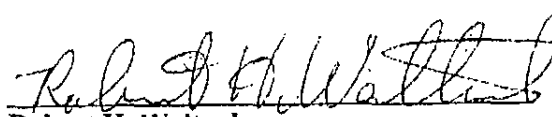
