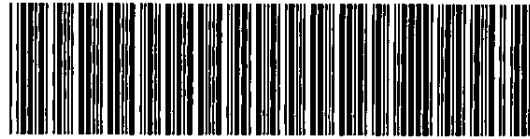

ARTICLES OF ORGANIZATION

Of

The undersigned hereby forms and establishes a limited liability company pursuant to Chapter 608, Florida Statutes, as follows:

ARTICLE I

The name of this limited liability company is PARQUE AURORA LLC (the "Company").


