The street and mailing address of the principal office of the Company are 2506 Phoenix Avenue, Jacksonville, Florida 32206.

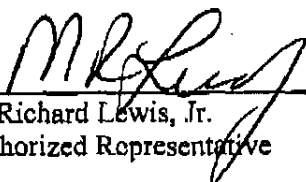
