**JOSE BUCAY– Fifty Percent (50%)**

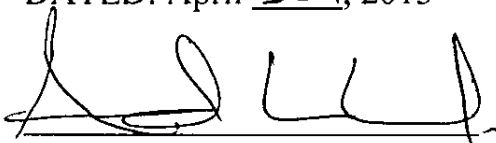
