ARTICLES OF ORGANIZATION OF IGUATEMI PROPERTY, LLC.

Pursuant to the provisions of Chapter 608 of the Florida Statutes (the "Florida Limited Liability Company Act"), the undersigned representative of the members, for the purposes of forming a Florida limited liability company, hereby adopts the following Articles of Organization:

ARTICLE I

The name of the company is IGUATEMI PROPERTY, LLC. (the "Company").

ARTICLE 2 DURATION AND PLACE OF BUSINESS

The period of duration of the Company is perpetual and its principal place of business is at 2950 NE 188 Street, Unit 427, Aventure, Florida 33180. The Company may also maintain an office or offices at such other place or places, either within or without the State of Florida as may be determined, from time to time, by the Company's manager.

ARTICLE 3 MAILING ADDRESS

The Company's mailing address will be at 2000 Ponce De Leon Blvd., Suite 617, Coral Gables, FL 33134.

ARTICLE 4 PURPOSE

The purposes for which the Company is organized are to engage in any lawful act or activity for which corporations may be organized under the Florida Limited Limbility Company Act.

ARTICLE 5 REGISTERED OFFICE AND REGISTERED AGENT

Subject to the provisions of the Florida Limited Liability Company Act, the following provisions are adopted for the management of the business and for the conduct of the affairs of the Company:

- 6.2. <u>Initial Manager</u>. The name of the Company's Initial Manager is <u>Cleber Brum</u> <u>Filho</u>, an individual, whose mailing address is 2000 Ponce De Leon Blvd., Suite 625, Corel Onbles, FL 33134.

ARTICLE 7 LIMITATION OF LIABILITY OF MANAGERS AND MANAGING MEMBERS

The liability of the managers and managing members of the Company for monetury damages shall be eliminated to the fullest extent permissible under Section 608.4228 of the Florida Limited Liability Company Act.

ARTICLE 8 INDEMNIFICATION OF COMPANY'S AGENTS.

Subject to the applicable limits set forth in Section 608.4229(2) of the Florida Limited Liability Company Act, the Company is authorized to provide indemnification of its members, managers, managing members, officers, employees, and agents through operating agreement provisions.
