# ARTICLES OF ORGANIZATION OF

# RAINY DAY INVESTMENTS, LLC

These Articles of Organization are made for the purpose of organizing a Florida Limited Liability Company under the Florida Limited Liability Company Act (Florida Statutes Chapter 608).

#### **ARTICLE I - NAME**


# **ARTICLE VIII - REGULATIONS**
