# **ARTICLES OF ORGANIZATION OF RAINY DAY INVESTMENTS, LLC**

These Articles of Organization are made for the purpose of organizing a Florida Limited Liability Company under the Florida Limited Liability Company Act (Florida Statutes Chapter 608).

## **ARTICLE I - NAME**

## **ARTICLE II - MAILING ADDRESS**


