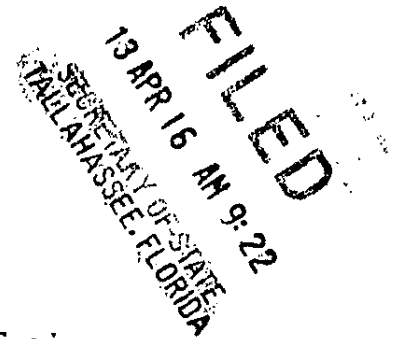
Article IV. Transferability of Membership Interests


