AMENDED AND RESTATED ARTICLES OF ORGANIZATION

HARBOR RETIREMENT SERVICES MANAGEMENT, LLC a Florida Limited Liability Company

Pursuant to the provisions of Chapter 608 of the Florida Statutes, the undersigned has executed and hereby files the following Amended and Restated Articles of Organization for such limited liability company.

The present name of the limited liability company is HARBOR RETUREMENT SERVICES MANAGEMENT, LLC (the "Company"); the date of filing of its original Articles of Organization with the Florida Secretary of State was April 17, 2013 and assigned Florida document number L13000056911.

The original Articles of Organization are hereby amended by being deleted in their entirety and restated as follows:

ARTICLE I. NAME

The name of the limited liability company is: HARBOR RETIREMENT MANAGEMENT, LLC (the "Company").

ARTICLE IL ADDRESS

ARTICLE III. DURATION

The Company shall be a manager-managed company. The manager or managers shall be appointed in accordance with the terms of the Company's Operating Agreement.
