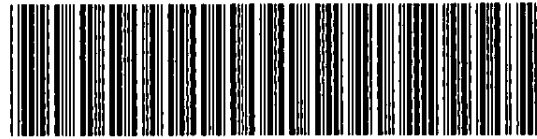

**ARTICLE I
NAME, PRINCIPAL PLACE AND MAILING ADDRESS OF BUSINESS**

The name of the limited liability company shall be Florida Seal Coat Supply, LLC and its principal office and mailing address shall be 5600 Carder Road, Orlando, Florida 32810, but it shall have the power and authority to establish branch offices at any other place or places as provided in the Operating Agreement, as it may be amended from time to time.

**ARTICLE II
DURATION**
