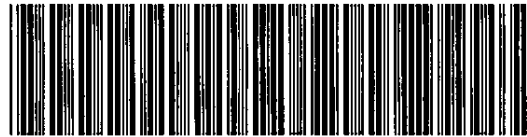

WHEREAS, the approval of the Secretary of State of the State of Florida of the proposed amendment is hereby requested.


