**ARTICLES OF ORGANIZATION

James, IV, a natural person competent to contract and an authorized representative of a member of Young Goss & Mitchell, LLC, hereby presents these Articles of Organization as the Articles of Organization of Young Goss & Mitchell, LLC, a limited liability company formed under the provisions of Chapter 608, *Florida Statutes*.

ARTICLE I - NAME

The name of the limited liability company is Young Goss & Mitchell, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS

The Company shall be managed by its members in accordance with the terms of the Operating Agreement for the Company. The name and mailing address of the initial member of the Company are as follows:

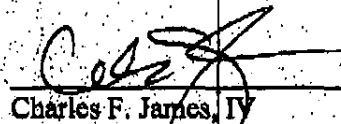

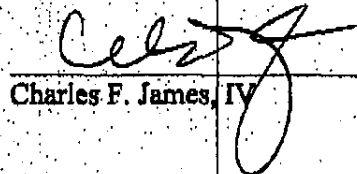
