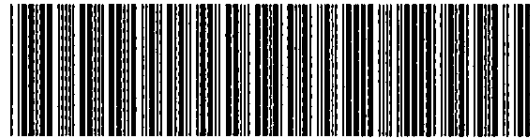

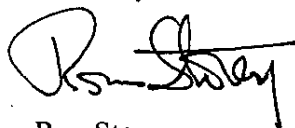

The undersigned for the purpose of forming a Limited Liability Company pursuant to Chapter 608 Florida Statutes, as amended (the "Florida Limited Liability Company Act"), hereby file the following Articles of Organization with the Secretary of the Department of State of the State of Florida, and affirm that the facts stated in these Articles of Organization are true and correct.

**ARTICLE I**

Name and Address of the Company

The name of the limited liability company is D & G H2O INVESTMENTS, LLC (the "Company"). The street address of the principal office of the company is 524A Highway 90, Chipley, Florida 32428, and the mailing address of the company is 524A Highway 90, Chipley, Florida 32428.

**ARTICLE II**

Duration

(2) The date upon which a dissolution occurs pursuant to the terms of the Operating Agreement of the Limited Liability Company, as in effect on the date an event of dissolution occurs.

### ARTICLE III

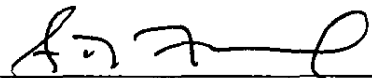
