

#### ARTICLES OF ORGANIZATION

OF

#### CATS IN THE HATT, LLC.

#### ARTICLE I - NAME

The name of the Florida limited liability company shall be CATS IN THE HATT, LLC.

#### **ARTICLE II - DURATION**

The duration of the Company shall be perpetual unless the Company dissolves in accordance with the provisions of the Company's regulations or these Articles of Organization.

## ARTICLE V - PERCENTAGE INTEREST; MEMBERSHIP CERTIFICATE

The profits and losses of the Company shall be allocated to the members in accordance with and in proportion to each member's Percentage Interest (which shall be equal to the number of Units owned by a member divided by the total number of Units owned by all of the members), unless otherwise provided in the Regulations of the Company.
