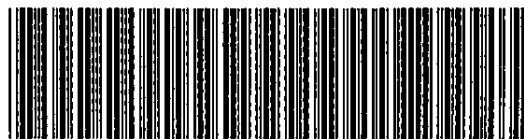

ARTICLES OF ORGANIZATION

OF

CATS IN THE HATT, LLC.

ARTICLE I - NAME

The name of the Florida limited liability company shall be CATS IN THE HATT, LLC.

ARTICLE II - DURATION

The duration of the Company shall be perpetual unless the Company dissolves in accordance with the provisions of the Company's regulations or these Articles of Organization.

ARTICLE VI - DISSOLUTION

ARTICLE VII - TRANSFERABILITY OF MEMBER'S INTEREST

If a majority of the Units do not approve the assignment, the assignee shall have no right to become a member, to participate in the management of the Company or to exercise any other rights or powers of a member. The assignee shall merely be entitled to receive the share of profits and other distributions and the allocation of income, gain, loss deduction, credit or similar item to which the assignor was entitled, to the extent assigned.
