**ARTICLES OF ORGANIZATION

1. Name. The name of the limited liability company shall be "Cabrillo Intermediate Holdings, LLC" (the "Company").

2. Mailing Address and Street Address. The Company's mailing address and street address in the State of Florida is as follows:

Through an amendment to these Articles of Organization, or through the Company's Operating Agreement, the Members of the Company may provide for the future creation of new or additional classes of membership interests having such relative rights, powers, and duties as the Members may determine, including, without limitation, rights, powers, and duties senior to the initial class or then existing classes of membership interests.

7. Duration. The Company shall not have a specific effective date of dissolution and shall be perpetual in accordance with the terms and conditions of the Company's Operating Agreement.

8. Effectiveness. These Articles of Organization shall be effective as of the date registered by the Florida Department of State, Division of Corporations.
