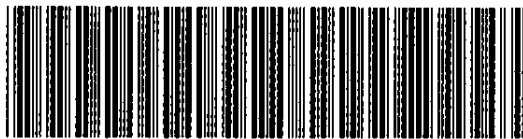

PURPOSE AND POWERS**


The Company is organized to engage in the practice of law and any other general business purpose, and shall have all powers provided by law and may use those powers to any lawful purpose.
