The mailing address and street address of the principal office of the Limited Liability Company is 135 San Lorenzo Avenue, Suite 750, Coral Gables, FL 33146.

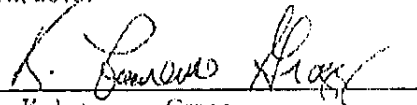
ARTICLE III - INITIAL REGISTERED AGENT
