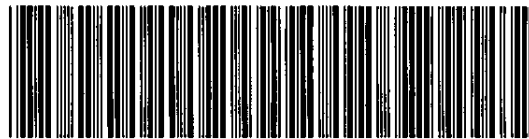

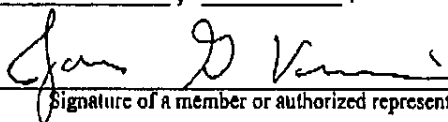

Before me, the undersigned authority, personally appeared JAMES G. VANVORIS, who being first duly sworn, states as follows:

1. I was the sole member of FLORIDA POWER EQUIPMENT & SALES LLC at the time it was created on April 29, 2013 and have remained the sole member of the company since then.
3. I did not authorize Richard L. Schroeder, Jr. to file the articles of amendment that were filed with the Division of Corporations on July 21, 2014, and said articles of amendment are false and fraudulent as Richard L. Schroeder, Jr. has never been a member of the company nor was he authorized by me, as the sole member of the company, to sign that document removing me as the sole member.
4. The Uniform Business Report filed on July 23, 2014 is a false and fraudulent document and was filed without my authorization. I did not agree to admit Richard L. Schroeder, Jr. as a member of the company.
5. I am filing contemporaneously herewith amended articles of organization reinstating my status as member and removing Richard L. Schroeder, Jr. as a registered agent and manager of the company to reflect company action taken on July 22, 2014.
