**ARTICLES OF AMENDMENT TO  
ARTICLES OF ORGANIZATION

Pursuant to the provisions of Section 608.411 of the Florida Statutes, INTERSTAR REAL ESTATE INVESTMENTS LLC, a Florida limited liability company (hereinafter, the "Company"), adopts the following Articles of Amendment to its Articles of Organization:

FIRST: The Articles of Organization of INTERSTAR REAL ESTATE INVESTMENTS LLC were filed on April 29, 2013, and assigned document number L13000062465.
