The mailing address and address of the principal office of the Company is 32 N. St. Andrews Drive, Ormond Beach, Florida 32174.

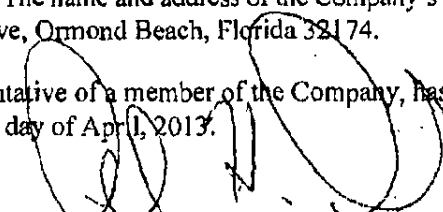
ARTICLE III - REGISTERED OFFICE/REGISTERED AGENT

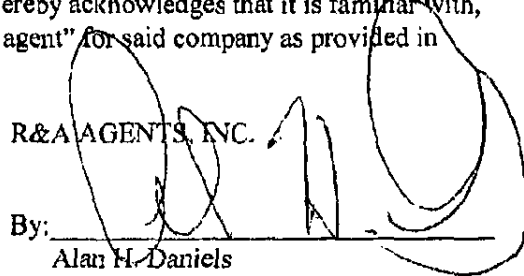
