**ARTICLES OF ORGANIZATION

The undersigned authorized representative hereby executes these Articles of Organization ("Articles") for the purpose of forming a limited liability company in accordance with the laws of the State of Florida.

**ARTICLE I**

**Name**

The name of this limited liability company (the "Company") shall be:

**ARTICLE II**

**Principal Office and Mailing Address**

The Operating Agreement of the Company shall be for the government of the Company and may contain any provisions or requirements for the management or conduct of the affairs and business of the Company, provided the same are not inconsistent with the provisions of these Articles or contrary to the laws of the State of Florida or of the United States.

## ARTICLE V

### Management of Business

The business of the Company shall be managed by Managers elected by the Members as provided in the Operating Agreement. The Managers may be, but are not required to be, Members of the Company. The Managers shall have the power and authority to act on behalf of the Company as provided in Chapter 608, Fla. Stat., as the same may be amended from time to time, and as further provided in the Operating Agreement of the Company.

## ARTICLE VI

### Amendment of Articles of Organization

The Company reserves the right to amend any provision of these Articles of Organization in accordance with the terms of the Operating Agreement.


