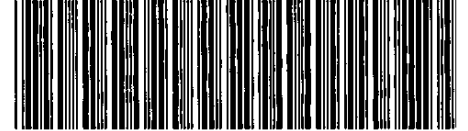

The Members of GENERA, LLC, identified in the Articles of Organization as MGRM are now identified solely as AMBR, Authorized Member without managing powers.


