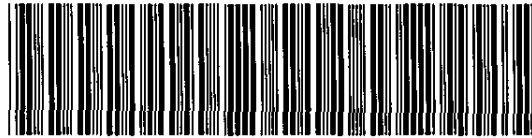

ARTICLE IV

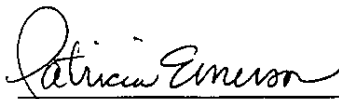

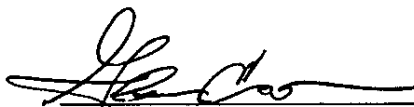
