
ARTICLE VI

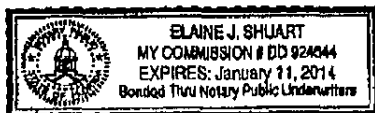


