

I soon realized that part of the company's name was misspelled (i.e., financial is incorrectly spelled). As such, I filed another set of Articles of Organization on 5/8/13 with the correct spelling BLACKBIRD FINANCIAL, LLC. However, I received the attached e-mail stating that the articles could not be filed because the name BLACKBIRD FINANCIAL, LLC was not distinguishable from an existing entity. I can only assume this is referring to the misspelled company.
