Pursuant to Section 605.0202 of the Florida Revised Limited Liability Company Act, this Florida limited liability company adopts the following Amended and Restated Articles of Organization:

- A. The name of the limited liability company is: Rescom Construction & Restoration, LLC.
- B. The Articles of Organization of the limited liability company were filed on May 13, 2013 and assigned document number L13000070025.
- C. These Amended and Restated Articles of Organization of Rescom Construction & Restoration, LLC were duly executed and are being filed in accordance with Section 605.0202 of the Florida Revised Limited Liability Company Act.
- D. The limited liability company's Articles of Organization are amended and restated in their entirety and replaced with the following:

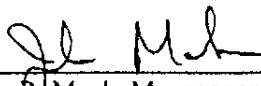
