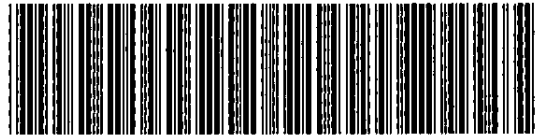

**ARTICLES OF ORGANIZATION  
OF

The undersigned hereby certifies that he is the Authorized Representative of a Member who is forming a Limited Liability Company under Chapter 608, Florida Statutes. The following Articles of Organization are hereby adopted.

**ARTICLE I.  
NAME**

The name of the Limited Liability Company shall be AFFORDABLE LIMB AND BRACE, LLC.

**ARTICLE II.  
DURATION; EFFECTIVE DATE**

This Limited Liability Company shall exist perpetually, commencing as of the 9<sup>th</sup> day of May, 2013.

**ARTICLE III.  
ADDRESS; PRINCIPAL OFFICE**

RESTRICTIONS ON TRANSFER OF MEMBERSHIP;

Upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a Member, or the occurrence of any other event that terminates the continued membership of a Member in the Limited Liability Company, the remaining Members shall have the right to continue the business upon affirmative vote of a majority of the remaining Members who hold voting interests.

OPERATING AGREEMENT**

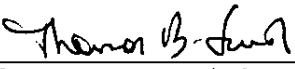

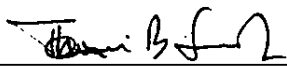
