**AMENDED AND RESTATED
ARTICLES OF ORGANIZATION
FOR
CALL DIRECT PARTNERS, LLC**

The undersigned, Amy Travers, a natural person competent to contract, and Advanced Enterprises of Northwest Florida, Inc., a Florida corporation, representing all the members of Call Direct Partners, LLC, a Florida limited liability company (the "Company"), hereby present these Amended and Restated Articles of Organization pursuant to the provisions of Section 605.0202, *Florida Statutes*. These Amended and Restated Articles of Organization have been duly adopted by the members of the Company.

FIRST: The Company's Articles of Organization were filed on May 15, 2013, with the Florida Department of State and assigned document number L13000071231.

SECOND: The Articles of Organization are superseded in their entirety by the provisions of these Amended and Restated Articles of Organization.

THIRD: The Company's Amended and Restated Articles of Organization (these "Articles") are set forth in their entirety as follows:

ARTICLE I - NAME

The name of the limited liability company is Call Direct Partners, LLC. This limited liability company is referred to in these Articles as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS

The street address of the Company's principal office as of the date hereof is 950 North Courtenay Parkway, #10, Merritt Island, FL 32953. The mailing address of the Company is 2183 W. Highway 98, Mary Esther, FL 32569. The Company's principal office may hereafter be at such other place or places as its members from time to time may determine.

ARTICLE III - PURPOSE AND POWERS

The Company is organized for any legal and lawful purpose for which a limited liability company may be organized and shall have all powers and rights which a limited liability company may exercise pursuant to Chapter 605, *Florida Statutes*.

**ARTICLE IV - EFFECTIVE DATE OF AMENDED AND RESTATED
ARTICLES OF ORGANIZATION AND TERM OF EXISTENCE**

The effective date of these Articles shall be the date these Articles are filed with the Florida Department of State. The Company shall have a perpetual existence unless the Company is terminated as provided in its Operating Agreement.


