

ARTICLES OF ORGANIZATION

OF

Madame Clasique, L.L.C.

The undersigned, being duly authorized to act as the organizer of this Limited Liability Company pursuant to Chapter 608 and Section 658.16, Florida Statutes, hereby forms a limited liability company under the laws of the State of Florida and adopts the following Article of Organization for such Limited Liability Company.

ARTICLE I – NAME

The name of the limited liability company shall be Madame Clasique, L.L.C. (hereinafter, the “Company”).

ARTICLE II – ADDRESS

The street address of the initial principal office and mailing address of the Company are:

ARTICLE III – PURPOSE

The general nature of the business to be transacted by the Company shall be that of a hair and beauty supply service business, in particular, but not limited to, the preparing and dispensing of hair and beauty supplies. As well as, any and all legitimate endeavors and enterprises under the applicable laws of the State of Florida, and these United States of America.

ARTICLE IV -- EFFECTIVE DATE AND DURATION

The term of existence of the Company shall commence with the filing of the Articles of Organization with the Secretary of State of the State of Florida, and shall continue perpetually, unless sooner dissolved in accordance with the laws of the State of Florida and the Operating Agreement of the Company. In no instance shall the Company be automatically terminated, dissolved, or operations suspended upon the occurrence of an event, including the death, disability, bankruptcy, expulsion, or withdrawal of a member of the Company, other than the passage of time as may be specified by law or the Operating Agreement of the Company. Provided, however, that upon any such termination event, the existence and business of the Company may be continued by amendment of these Articles of Organization or the Operating Agreement providing for the continued existence of the Company as may be authorized by Florida Statutes.

ARTICLE V -- MANAGEMENT AUTHORITY

The exclusive authority to manage the Company is vested in the named Manager contained herein within the Articles of Organization, unless and until such authority is duly amended as may be specified by law or the Operating Agreement of the Company. Said Manager shall operate in substantially the same manner as, and have substantially the same rights, powers, privileges, duties, and responsibilities as, a director of a company chartered as a corporation.

ARTICLE VI – LIMITED LIABILITY OF MEMBERS

No Member of the Company shall be liable for the debts, liabilities, or obligations of the Company in excess of the amount of the Member's investment.

ARTICLE VII – TRANSFER OF OWNERSHIP RIGHTS

A Member may transfer an ownership interest in the Company, including voting rights, without the consent of any other Member of the Company, providing however, the transfer complies with all applicable requirements of law of the State of Florida and the Operating Agreement of the Company.

ARTICLE VIII – LIMITATION ON AGENCY AUTHORITY OF MEMBERS

Pursuant to Section 608.4235, Florida Statutes, no Member of the Company shall be an agent for the Company solely by virtue of being a Member, and no Member shall have authority to incur debt or contractual liability on behalf of the Company solely by virtue of being a Member.

ARTICLE IX – REGISTERED OFFICE AND REGISTERED AGENT

The street address of the initial registered office of the Company in the State of Florida shall be 1723 Grand Isle Drive, Brandon, FL 33511. The name of the registered agent of the Company at that address is Dara Nanyamka McCoy.

Having been named as registered agent and to accept service of process for the above stated limited liability company at the place designated in this certificate. I hereby accept the appointment as registered agent and agree to act in this capacity. I further agree to comply with the provisions of all statutes relating to the proper and complete performance of my duties and I am familiar with and accept the obligations of my position as registered agent.
