ARTICLES OF AMENDMENT  
TO ARTICLES OF ORGANIZATION

1. The name of the Company is Rosie's Playschool III, LLC.
2. The Articles of Organization for the Company were filed with the Florida Department of State effective May 20, 2013 and were amended by Amendment filed May 24, 2013.
3. Article V of the Company's Articles of Organization, is deleted in its entirety and the following is substituted therefore:

"ARTICLE V

The Limited Liability Company shall be managed by one or more managers and is, therefore, a manager-managed limited liability company.
