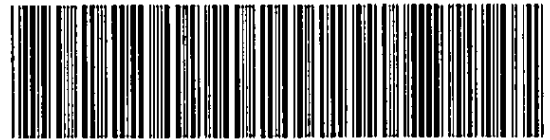

STATEMENT OF FACTS

To: Florida Department of State, Division of Corporations

Date: March 15, 2021

To whom it may concern,

I, Richard Beyer, would like to file Notice of Limited Liability Company Dissolution for Beyer Holdings, LLC, document number L13000073221, attached with this Statement of Facts.

Someone named Steven E. Krejci from Houston, TX fraudulently filed a reinstatement. I learned about this because a law firm sent me a letter to my home address regarding Steven E. Krejci as Registered Agent for Beyer Holdings, LLC (pertaining to an auto accident in Key West).

I **do not know** who Steven E. Krejci is at all. This company had no activity, had no operations, and was NOT sold.

Beyer Holdings, LLC was a company I started when I was considering to buy an existing business in Jacksonville on May 20, 2013. I did not move forward with the purchase and the company dissolved immediately. My CPA at the time recommended that I do nothing, since the entity never had any activity and did not file any annual statements.

In 2020, Steven E. Krejci fraudulently reinstated this Florida LLC and changed the Registered Agent. Again, I do not know him and this company was not an active company. It also appears that he filed an annual report on the same day for the previous 3 years (2018, 2019, and 2020). Further, he changed the company mailing address (16110 Hollister St. Houston, TX 77066), but kept my home address as [his] address (1685 Fenton Ave. St. Johns, FL 32259), which is my personal residence.

It appears this person, Steven E. Krejci, is a Registered Agent for many companies, *including* Beyer Holdings, LLC registered in the state of Texas:



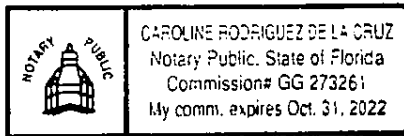
