ARTICLES OF ORGANIZATION
OF
3747 FOUNTAINHEAD, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I -- NAME

The name of the limited liability company shall be 3747 Fountainhead, LLC ("Company").

ARTICLE II -- ADDRESS


ARTICLE VII – TERMINATION OF EXISTENCE


