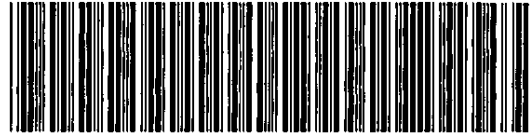

The dissolution was approved by the Manager and adopted by the Members on December 31, 2013, to be effective as of the filing date of the Articles of Dissolution.


All of the Members of the Company have provided their written consent to the dissolution of the Company.


All debts, obligations and liabilities of the Company have been paid or discharged.
