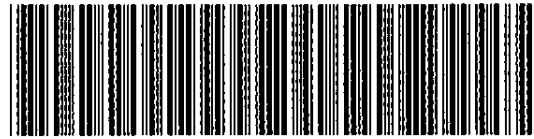

The name of the Limited Liability Company is WEST BRICKELL HOTEL PROMOTIONS, LLC (the "Company").


ARTICLE II - Address


