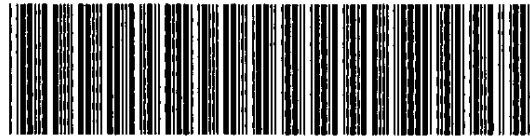




Article VII
