**ARTICLES OF ORGANIZATION
OF
NF SPORTS LLC**

The undersigned, being the duly authorized representative of the sole Member of the Company to be formed hereby, desiring to form a limited liability company under and pursuant to the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, does hereby adopt the following Articles of Organization:

**ARTICLE I
NAME**


