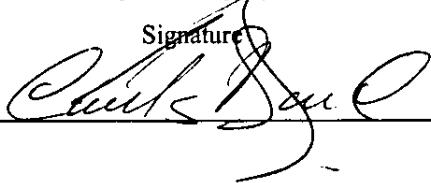
The President Carlos R. Daza and the Vice President Roberto J. De Fex
