

AMENDED AND RESTATED ARTICLES OF ORGANIZATION OF BNJ BLUEBERRY, LLC

THIS IS TO CERTIFY THAT:

FIRST: The undersigned, being the sole member of BNJ Blueberry, LLC, a Florida limited liability company, hereby consents to the following Amended and Restated Articles of Organization of BNJ Blueberry, LLC.
