**ARTICLES OF ORGANIZATION

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

**ARTICLE 1 – NAME**

The name of the limited liability company shall be **MIAMI TRANSFER GROUP, LLC**, ("Company").

**ARTICLE 2 – ADDRESS**

The principal place of business of the Company in Florida shall be 1925 SW 82<sup>nd</sup> Court, Florida 33155 and the mailing address shall be 2290 Lowell Ridge Rd Apt E, Baltimore MD 21234.

**ARTICLE 3 – EFFECTIVE DATE**

These Articles of Organization shall be effective on June 01, 2013.

**ARTICLE 4 – DURATION**

#### ARTICLE 6 - REGISTERED AGENT AND REGISTERED OFFICE

These regulations may contain any provisions for the regulations and management of the affairs of the Company not inconsistent with law of these articles of Organization. 
