The name of the limited liability company is: Willie Taggart, LLC.

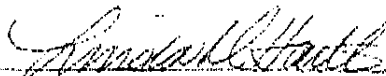
ARTICLE II. ADDRESS

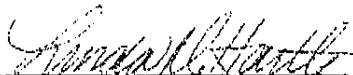
