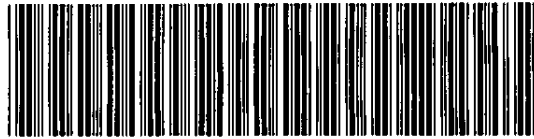



1. Paragraph 3 of the Articles of Conversion is hereby corrected by amending it in its entirety to read as follows:

*The "Converted or Other Business Entity" is a Sociedad Anónima de Capital Variable to be organized, formed or incorporated under the laws of the United Mexican States on such date, subsequent to the effective date of conversion in Florida, on which the Mexican public deed approving the conversion of such entity becomes effective.*
