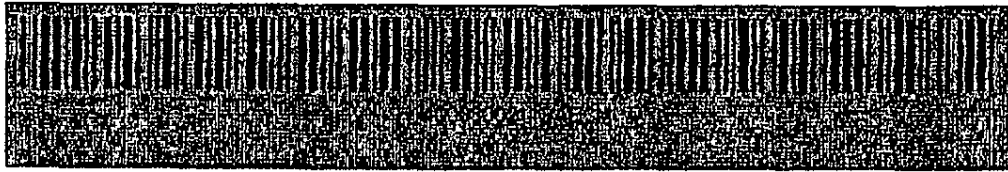


Article III of the Articles of Organization is hereby deleted in its entirety and replaced with the following new Article III:


