**AMENDED AND RESTATED ARTICLES OF ORGANIZATION
OF

Pursuant to the Florida Limited Liability Company Act, Chapter 608 of the Florida Statutes (the "Act"), the undersigned desiring to amend and restate the articles of organization of SOLARIS GLOBAL ENERGY LLC, a limited liability company (the "Company") duly organized and existing under the laws of the State of Florida as filed with the Florida Department of State on June 5, 2013 and assigned document number L13000081184. The undersigned confirms that these Amended and Restated Articles of Organization were duly executed and are being filed in accordance with Section 608.411 of the Act. The following Amended and Restated Articles of Organization hereby amend and restate the provisions of the Company's original Articles of Organization in their entirety:

**ARTICLE I
NAME**

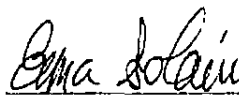

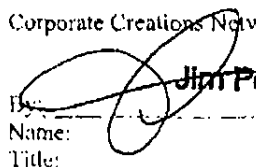
