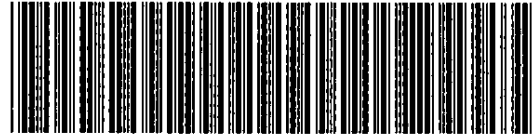

# ARTICLES OF ORGANIZATION FOR ADVANCE OPTIMAL HEALTHCARE P.L.

(a Professional Service Limited Liability Company)

This Professional Limited Liability Company ("P.L.") is organized under the provisions of Chapter 608 and 621, Florida Statutes, for the purpose of providing such professional services as specified below.

## ARTICLE I — NAME

The name of the Professional Limited Liability Company is:

## ARTICLE II — ADDRESS

## ARTICLE III — AREAS OF PRACTICE

The areas of practice of the P.L. are to provide professional nursing services, including those of nurse practitioners, and related health services; and, to conduct or promote any lawful business or purpose that a professional limited liability company is legally allowed to conduct or promote within this state or any other jurisdiction.
