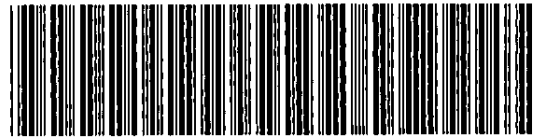

The name of the Limited Liability Company is CD GROUP V, LLC (the "Company").


